I am prepared to make a statement under oath in the application proceedings known to your court under Case/Role Number C/17/199273 /HARK 25/17 regarding the questions formulated in the application and related topics.

This request was denied by your court. Due to the enormous public interest in being able to present my expert opinion to your court in the context of a procedural debate, I have, at the

request of attorney Mr. Stassen, put in writing the statement I had intended to make before your court truthfully under penalty of perjury.

I have prepared this written report with the express offer to further explain my statement before your court and to enter into a debate with all parties, and in particular with the experts the defendants believe they can rely on.

I would like to emphasize that a truly open, public expert debate on the Covid-19 mRNA injections has been rendered impossible, within a context in which I and other investigators have been censored on the one hand and discredited on the other -- by the implementers of the Covid-19: The Great Reset project -- on the basis of our factual and legal findings, which contradict the claims made by the implementers of the Great Reset project -- and on the basis of our opinions interpreting the moral, political and legal significance of our factual and legal findings.

I expressly declare, and am willing to do so under oath, that I am independent, have independently conducted the research upon which my expert report is based, do not work for any of the parties in the aforementioned proceedings, nor do I have any interests in any of them. Regarding my expertise, please refer to the enclosed curriculum vitae.

It is my expert witness opinion that all vaccines, including *but not limited to* vaccines labeled and used as "Covid-19 mRNA" vaccines, are a class of *legalized* biological weapons with widely varying physico-chemical compositions (across batches, lots, vials and other quantities) used by the perpetrators of the Covid-19: The Great Reset project to harm recipients by causing or inducing damage to organs and organ systems of living human beings, biological malfunction, infertility and death.

Acts contributing to or participating in manufacture, distribution and use of these biological weapons (all vaccines and vaccine-related biological products) have been legalized by the US Congress and US Presidents and by the governments of countries that have contracted to purchase vaccine supplies from US-based or US-partnered vaccine manufacturers.

These legalized biological weapons have been used for many decades to reduce fertility, vitality and longevity among targeted human populations.

It is my expert witness opinion that acts contributing to or participating in manufacture, distribution and administration of any vaccine, including but not limited to any "Covid-19 mRNA" vaccine, are war crimes *shielded from prosecution* by enabling international and US federal laws and legal instruments.

Because I wish to personally inform you, the judges in this case, regarding its enormous social significance, I have attached a video message addressed to you in anticipation of an opportunity to give her statement in court. In this video message, I briefly explain the content of my statement and why I cannot reach a different conclusion.
